



## **EARL WARREN SHOWGROUNDS RV RULES AND REGULATIONS**

PURSUANT TO THE CALIFORNIA RECREATIONAL VEHICLE OCCUPANCY LAW, THE RECREATIONAL VEHICLE OF ANY RV OCCUPANT MAY BE REMOVED FROM THE PREMISES WITHOUT A JUDICIAL HEARING UPON 72 HOUR WRITTEN NOTICE TO OCCUPANT FOR: 1) FAILURE TO PAY FOR SUCH OCCUPANCY, OR 2) FAILURE TO COMPLY WITH THE RULES AND REGULATIONS OF THE PARK. CIVIL CODE SECTIONS 799.22, 799.43, 799.58

- All reservations must be made and paid for in the form of a credit card. No personal checks accepted.
- Renter agrees to be fully responsible for any breakage, damage, or destruction caused by Renter or Renter's guest during the term of this rental or any extension or renewal thereof.
- Refund policy: A full refund will be given if cancelled 15 days prior to your reservation, less a **\$20.00 processing fee per site reserved**. Reservations cancelled between 5 to 14 days in advance will be charged for one night stay per site. Cancellations within 4 days or less will not be refunded.
- Maximum stay of 15 consecutive days, Spaces is limited. Reservations will be held without prior payment.
- Vehicles must always display proper permits.
- Renter must show current proof of vehicle registration and insurance during stay.
- Extra vehicles: Each RV site includes one (1) additional vehicle parking in the parking lot. There will be a \$20.00 charge per day for any extra vehicles.
- No vehicles are to park in RV area, they must be parked in parking lots adjacent to the RV lot.
- Spaces are back in only.
- All RV's/Campers/Vehicles must be contained within the assigned site.
- Only one RV or trailer per site. Any RV/Campers/Vehicles taking more than one site will be charged for the additional site used. No parking in empty/unoccupied sites.
- All vehicles must be in compliance with the California Department of Motor Vehicles.
- There is no storage of any type allowed around the RV's, Campers and or vehicles. All RV sites must be kept clean for the enjoyment of all occupants.
- No washing of any vehicles or repairs of any kind are permitted.
- Non-contained fires for cooking and or heating is prohibited and not permitted.
- Any type of fencing, barriers, pallets etc. are not permitted.
- There are no tents allowed on any RV sites.

- Alcohol, drugs, weapons, fighting, lewd conduct, reckless driving, speeding, skateboarding, loud noise or any conduct deemed to be a nuisance and or a violation of law is not permitted. Violators will be evicted from the facility.
- Bicycles must be ridden in RV section only.
- Quiet time is from 10:00 p.m. to 7:00 a.m.
- Advertising or distribution of any product (including alcohol) is prohibited.
- The dumping of sewage onto the ground is in violation of the California Health and Safety Code, Section 5411. All sewage from RV's and campers must be confined and then properly disposed of to the public sewage system via dumping stations. Units found to be in violation are liable and will be prosecuted.
- Dogs must be licensed and kept on a leash (max. 6 ft.) at all times and cannot be tied to a vehicle or left alone. Dogs must be walked in the pet run. Occupants will be evicted if their dogs engage in excessive barking or demonstrate aggressive behavior. You must clean up after your pet. A \$25.00 per incident will be issued.
- RV occupants and their guests must obey all district rules and regulations, as well as any direction of the RV park manager and the district security. Failure to comply with these rules and regulations can result in eviction or other action.
- There will be NO REFUNDS for occupants of the facility. Guests are responsible to assure that their vehicle fits within the specified measurements. Oversize vehicles will not be allowed. No refunds to oversized vehicles.
